- The restricted stock units vest and settle in three equal annual installments beginning on the first anniversary of the grant date.
- Ms. Robertson's right to receive a cash payment of \$522,517 under the approved modifications to the Company's overall compensation program, which modifications were disclosed in the Company's Current Report on Form 8-K filed on July 2, 2020, was subject to the forfeiture of these restricted stock units.
